The role of committee members

The Source Protection Committee's role is to guide the collaborative process that identifies the sources of drinking water, the threats to both water quality and water supplies, develop the programs and policies that will reduce the risks to drinking water sources and report on implementation.

The committee guides the update of the Halton-Hamilton Source Protection Plan and comments on the progress made to implement the plan through annual progress reports. Plan development involves municipalities, farmers, businesses, industry, residents and others. Members of the committee are expected to participate fully and work positively toward solutions.

NOTE: To be eligible to apply to the Halton-Hamilton Source Protection Committee, you must:

- reside in, own or rent property within the Halton-Hamilton Source Protection Region; OR
- be employed or operate a business within the Halton-Hamilton Source Protection Region; OR
- be employed by a municipality that is part of the Halton-Hamilton Source Protection Region; AND
- not be a member or employee of a conservation authority within the Halton-Hamilton Source Protection Region.
